Webinar Meeting Hosting SOP & Continue Education Hours Tracking:

- Webinars have been going well.
- Only issue is that there have been questions from members regarding CEH credits. Karen changed the webinar information noting that FL AWRA only gives CEHs to PEs.
- Shayne noted that FL AWRA has always given CEH credits for PEs because it is a lot to manage to provide CEHs for additional professions such as Professional Hydrologists or Lawyers. If FL AWRA wants to branch out in CEHs, then the CEH committee would need additional members to help with the additional amount of work this would create. There is also a concern that other disciplines require specific certification. Therefore, it would take additional research and support for each discipline that FL AWRA would like to offer CEH credits in.
- Many members felt like the CEH credits should be expanded to other disciplines, but it was also recognized that Shayne would need additional support if FL AWRA were to do so.
 - Roger volunteered his team to help with providing credits to the geologists.
 - o Karen volunteered to investigate what it would take for certification for the planners.
 - Shayne noted that ideally, we would get perpetual recertification. There can be issues with recertification and FL AWRA would want to avoid any liability.

Audit Committee: Woody will connect with his auditor contact for additional information. It was discussed that an auditor could provide FL AWRA with an audit guidance document so that FL AWRA members could conduct an internal audit. Woody will investigate and report back to the Board.

Meetings:

- May Meeting Recap—The meeting went very well and FL AWRA was given great feedback for coverage of unique technical items.
- Tampa Bay Area Recovery and Wellhead Protection Recap: Patrick Tera—covered two different topics and it was also well attended.
- June 18th—Sam noted that they are in good shape and raised about \$2,000 and have close to 70 registrations.
- It was noted that webinars have been so successful that they could potentially continue in the future if we wanted to add in addition to traditional technical in-person meetings.

 - There were a few challenges as some of the recommendation letters were not attached to the application. Gordon would like to receive feedback on the process from the committee and report back to the Board.
